



After being banned from sailing in the U.S. since March 2020, the first large ocean ships have been given the green light by the CDC to start sailing again.

he Great Pause in U.S. cruising looks to be coming to an end. On June 26, Celebrity Cruises plans to be the first major ocean cruise line to sail from a U.S. port in more than a year when the 2,918-passenger *Celebrity Edge* departs from Ft. Lauderdale, Florida, for a seven-night Caribbean cruise.

The U.S. Centers for Disease Control and Prevention (CDC) has given the go-ahead to Celebrity on the basis that all crew members will be vaccinated for COVID-19 and all U.S. passengers age 16 and older will be fully vaccinated as well. (All vaccine doses must be administered at least 14 days prior to sailing.) Starting August 1, 2021, all U.S. guests age 12 and older on Celebrity vessels must be fully vaccinated, too.

In late April, the CDC sent a letter to cruise lines clarifying its rules for the restart of sailings from the United States amid the ongoing coronavirus pandemic. The agency stated that ships must show that 95 percent of crew and guests are vaccinated to avoid a rigorous test cruise process. The 5 percent leeway for vaccinated passengers would mean only a very limited number of unvaccinated youngsters could sail onboard.


There is one small (OK, potentially major) problem—just as Celebrity announced its CDC-approved plans to restart sailings, Florida Governor Ron DeSantis stated that cruise lines operating out of Florida can't make being vaccinated a requirement for passengers.

"What the CDC has done by closing the cruise industry for over a year, they do not have the authority to do it. You cannot have just some bureaucracy that doesn't have the legal authority to do this . . . shut down commerce," Governor DeSantis said during a May 28 press conference.

He added that he is confident that Florida will win its case against the CDC and said that whatever the outcome, "We are going to enforce Florida law. We have laws to protect the people and the privacy of our citizens and we are going to enforce them."

Following the relaunch of sailings on the *Celebrity Edge*, Celebrity plans to bring the *Celebrity Equinox* back to U.S. waters on July 18, with CDC-approved departures from Ft. Lauderdale. The two vessels will sail a seven-night western Caribbean itinerary that includes the Bahamas, Grand Cayman, and Costa Maya and Cozumel in Mexico. They will also sail a seven-night eastern Caribbean cruise making stops in the British Virgin Islands, St. Maarten, Puerto Rico, and the Dominican Republic.

Those relaunches follow the reintroduction of the *Celebrity Millennium*, which returned to service in the Caribbean island of St. Maarten on June 5 with seven-night cruises that include Aruba, Curaçao, and Barbados

Grilled Salad Pizza



Pizza:

- 1 cup fresh ricotta
- 1 dove garlic, finely chapped
- 2 to 3 tablespoons heavy cream or whole milk
- Kosher sait and freshly ground black pepper
- Extra-virgin ofter of, for brushing
- 1 pound prepared pluza dough, at room temperature
- 1 1/2 cups shredded mozrarella
- 1/4 cup grated Parmesan
- 1/4 cup grated pecorino
- Crushed red pepper flakes, for garnish
- Dried oregano, for gamish

Ingredients:

Salad:

- 2 tablespoons red wine vinegar
- Kosher sait and freshly ground black pepper
- 1/4 teaspoon dried oregano
- 3 tablespoons edra-virgin olive oil
- 1 tablespoon grated Parmesan
- 1 clove garks, crushed and peeled 1/2 cup halved cherry tomatoes
- 1 Persian cucumber, cliced
- 1/4 small red onlon, sliced
- 1/2 cup drained plantiniera, choosed
- 1/2 cup drained marinated artichoke quarters, chopped
- 1/4 cup pitted black Italian olives, such as Gaeta, halved
- 2 ounces thickly sliced provolone, cut into strips 1 ounce sliced Genoa salami, cut into strips
- a position stated decision payorilly contribute
- 2 hearts of romaine, chooped

Directions:

- 1 Prepare a grill for medium heat.
- 2 For the salad: Whisk the vinegar, 1/2 teaspoon salt, several grinds of pepper and the oregiano together in a large salad bowl. Slowly whisk in the oil to make a smooth dressing, Whisk in the Parmesan. Add the gartic clove and let sit for about 30 minutes to infuse (about as long as it takes to prepare the ozzal).
- 3 Just before serving, discard the gartic clove. Add the tomatoes, oucumber, red onlon, glandiniera, artichokes, olives, provokine and salami to the bowl and toss to cost. Add the romaine and toss again.
- 4 Meanwhile, for the pizza: Str together the ricotta and chopped gartic in a small bowl. Stir it circling nearm or milk to make a spreadable mixture. Season with sait and peoper. Brush a 14-inch or larger pizza pan with oil. Form the pizza dough into a bail and place on the pan. Brush the dough with oil. Use you fingers to gently stretch the dough to a 12- to 13-inch round. Brush the top of the dough once more with oil.
- Quickly flip the pizza over the grill and remove the pan, leaving the dough round on the grill. Grill, covered, until the bottom of the dough is golden, has distinct grill marks and the top is set, about 3 minutes. Flip the dough so the grilled side is up. Brush the crust with olive oil. Spread the ricotta mixture aimost to the edges. Sprinkle with the mozzaretia, Parmesan and peccrino. Cover the grill and cook until the cheese is melted and the bottom crust is crisp and recident bloody from tes.
- 6 Remove the pizza from the grill and cut into 8 slices. Sprinkle the pizza with red peoper flakes and oregano. Pile the salad on log and serve.

N.J. named best state to live in by national website

New Jersey was named the "best state to live in" overall, according to an analysis by the financial website WalletHub.

The state landed in first place on the website's "2021 Best States to Live in" rankings and received high marks in the "Health and Education" category, coming in fifth place on the list.

It also ranked fourth in "lowest crime rate," and ranked in the top 10 for "quality of life," according to the survey.

It lagged in areas of affordability, where it ranked 49th on the list, and in economy, where it ranked toward the middle compared to other states.

WalletHub's survey took into account 52 weighted metrics, including property taxes and cost of living as more important factors, as opposed to movie theaters per capita and low birth weights, which were deemed less important factors.

REAL ID Deadline Pushed Back to May 2023



The United States Department of Homeland Security announced that the DHS was extending the REAL ID full enforcement date by 19 months, from Oct. 1, 2021, until May 3, 2023, because of the impact of COVID-19 on the enforcement.

The news means that most Americans who want to travel domestically on an airplane without a passport or enhanced driver's license will be able to do so until at least May 2023.

After that, every air traveler 18-years or older will need a REAL ID-compliant driver's license, a state-issued enhanced driver's license, or a passport in order to get through TSA security checkpoints for domestic travel.

According to the DHS, the pandemic "significantly impacted states' ability to issue REAL ID-compliant driver's licenses and identification cards, with many driver's licensing agencies still operating at limited capacity."

"Protecting the health, safety, and security of our communities is our top priority," said Secretary Mayorkas. "As our country continues to recover from the COVID-19 pandemic, extending the REAL ID full enforcement deadline will give states needed time to reopen their driver's licensing operations and ensure their residents can obtain a REAL ID-compliant license or identification card."

The REAL ID comes from legislation passed by Congress in 2005 aimed to unify security standards for the IDs across states.

Tuesday's announcement is also not the first time the deadline has been pushed back. In fact, this is also not the first pandemic-induced delay in implementation—in March 2020, at the onset of the pandemic, the DHS pushed in back indefinitely because of COVID-19, eventually landing on Oct. 1, 2020, and then pushing it back again a full year to Oct. 1, 2021.

In a statement reacting to the news, U.S. Travel Association EVP of Public Affairs and Policy Tori Emerson Barnes called the delay "the right move."

"Extending the REAL ID deadline is the right move, and we're grateful to DHS for heeding the evidence and the calls from our industry. Getting to REAL ID compliance on time was already going to be a challenge before COVID shut down DMVs for extended periods. Significant travel disruption was likely if the deadline were allowed to hit, which the U.S. economy can't afford after a \$500 billion decline in travel spending last year and millions of travel jobs lost to the pandemic."
