Here Is Some of the New CDC Guidance on Cruise Ship Travel

This week, news came out that the Centers for Disease Control and Prevention (CDC) was sunsetting its Program for Cruise Ships Operating in U.S. Waters effective immediately, opting for a new set of guidelines for public health operations on cruise ships.

The CDC made the announcement on Monday, writing on its website that, "as of July 18, 2022, CDC's COVID-19 Program for Cruise Ships is no longer in effect" and it will no longer update pages that tracked cases onboard ships. Some cruise lines, like Virgin Voyages, moved to drop some COVID-era restrictions after the news came down this week.

On Thursday, the CDC posted a new set of guidelines, which are not mandatory for cruise lines operating U.S.-based sailings. The CDC said the guidelines were published "to assist cruise ship operators in establishing health and safety protections to reduce the risk of introduction and spread COVID-19 during passenger operations and preserve onboard medical capacity."

"Cruise ship operators should carefully consider and incorporate these recommendations in developing their own health and safety protocols. Plans should include triggers for a graduated approach to outbreak management in response to increasing case counts or other public health concerns," it added.

Pre-Cruise Health Screenings

"Cruise ship operators should screen passengers for signs or symptoms of COVID-19, known close contact exposure to a person with COVID-19 within the 10 days before embarkation, or a positive COVID-19 viral test within 10 days before embarkation," the CDC wrote in its new update.

Vaccination Requirements

The CDC is no longer requiring cruise ships to operate vaccination-only voyages. However, its new update is still recommending that "all eligible travelers be up to date with their COVID-19 vaccines.

Testing Requirements

Cruise lines no longer have to require guests to test before embarkation, but the CDC is still recommending it, too.

Onboard Response Plans

The CDC is still recommending that cruise line operators have a plan in place for a COVID-19 outbreak during a sailing, including isolation, quarantine protocols, and a medical facility onboard to be able to treat those who are infected and ill. That includes some kind of "surveillance protocols" to detect COVID-19 in passengers, isolation and quarantine protocols, medical facilities onboard, and the ability to "provide hospital level of care...for infected patients without the immediate need to rely on shoreside hospitalization."

If an infection does happen, fully vaccinated close contacts should either be tested with a viral test daily until 5 days after exposure or quarantined until at least five full days after their last exposure. Those who aren't up to date with their vaccines should either be quarantined for five days with daily testing and then wear a well-fitting mask when outside their cabin, or quarantined until at least 10 days after exposure.

Cruise lines should also have procedures in place for disembarking travelers with COVID-19 "who need a higher level of care that can be provided onboard" and "training protocols for all crew on COVID-19 prevention, mitigation, and response activities."

Disney World's next-gen MagicBands arrive on July 27

MagicBand Plus devices also light up and interact with Disney's nighttime spectaculars.

U. S. PASSPORT WAIT TIME IS NOW 8 to 11 WEEKS

FOR 'ROUTINE SERVICE'

Getting a U.S. passport renewed still takes longer than it did pre-COVID, but wait times have improved since the worst of the pandemic, according to a U.S. State Department spokesperson speaking to TMR this week.

According to that spokesperson, passports are now being issued within 8 to 11 weeks for routine service and as little as 5 to 7 weeks for expedited service, time periods that cover "when an application arrives at a passport agency until we issue a passport."

That turnaround time is longer than it was in 2019 when the State Department increased the typical processing time from 4 to 6 weeks to 5 to 7 weeks, but still a major improvement over what some travelers have experienced over the last two-plus years.



During the pandemic, wait times, at certain periods, were stretching into 18 weeks. Travel advisors speaking to TMR at the time said that the wait times were a major issue for clients, many of who were forced to cancel or postpone trips because of extended turnaround time.

Since then, the U.S. State Department promised more staff to help with the delays and an executive order signed in December 2021 promised to allow Americans to renew their passports securely online with "safety security" and to make it easier to connect with TSA in order to get questions and concerns answered.

The increase in staff has helped processing times return to closer-to-normal, but still, the spokesperson told TMR that "to avoid

Those who are traveling with less time to spare are able to schedule an in-person appointment at a regional passport agency in order to expedite the process. Those appointments can be scheduled only via a phone call and only within 2 weeks of the travel date. Applicants will be required to provide proof of travel when making the appointment.

According to the State Department, that is the quickest way to get a passport. Other options, including passport expediting companies and other private companies that charge fees for a quick passport turnaround, will not get travelers their passports any quicker than they would by applying through a regional passport agency.

Perfectly Baked Beans

Ingredients:

- 4 slices regular bacon, diced
- 1 medium onion, cut into small dice
- 1 medium green bell pepper, cut into small
- 1 red bell pepper, out into small dice
- 1 fresh jalapeno, chopped
- 4 large cans (28 ounces each) pork and beans
- 1 cup barbeoue sauce
- 1/2 cup brown sugar
- 1/4 cup distilled or cider vinegar
- 2 tablespoons ketchup
- 1 tablespoon yellow mustard
- 2 chipotle peppers, minced
- 6 slices thin bacon



Directions:

 Adjust the oven rack to the lowermiddle position and preheat the oven to 325 degrees F. 2 Fry the regular chopped bacon in a large, deep skillet until the bacon has partially cooked and released about 1/4 cup drippings. Add the onlans. peppers and jalapenos, and saute until tender, about 5 minutes. Add the beans, barbeque sauce, brown sugar, vinegar, ketchup, mustard and chipotles, and bring to a simmer. (If the skillet is not large enough, add the beans and heat to a simmer and then transfer to a large bowl and stir in the remaining ingredients). Pour the flavored beans into an aluminum pan. Top with the uncoaked slices of bacon (you can halve the slices if you like). Then bake until the beans are bubbly and the sauce is the consistency of pancake syrup, about 2 hours. Let stand to thicken slightly and serve.



Mask Mandates Are Returning at These National Parks

Due to a rising number of COVID cases, the National Park Service has reinstated mask policies in indoor spaces for some parks.

What do Denali, Glacier, Grand Canyon, Grand Teton, Yellowstone, and Yosemite national parks have in common? In addition to being some of the largest and most popular protected public spaces in the United States, they've all recently reinstated indoor mask policies due to a rise in COVID cases throughout the country.



The new mandates are based on a Department of Interior policy that is informed by the U.S. Centers for Disease Control and Prevention's COVID-19 community levels, classifications that rank community caseloads as either "low," "medium," or "high." Currently, the towns in and around the above national parks are experiencing high levels of COVID transmission.

Because all national parks adhere to Department of Interior guidelines, it's a good idea to check the individual park's website or download the NPS app for information on current COVID measures before visiting any given national park in the U.S.

Grand Canyon National Park said that it has reinstated the "masking requirements to protect our community, park employees, and visitors." Grand Canyon added that its leadership decided that it will only remove the masking restrictions after two consecutive weeks of "medium" COVID-19 community levels.

"We are concerned with cycling back and forth from week to week as the COVID pandemic develops and changes," the park stated. "Park leadership's efforts are to strive for consistency in policy and process and ensuring our operations and staff are as safe and secure as possible."

Although Grand Canyon won't remove the mandate until there have been two consecutive weeks of reduced cases, the NPS said it is up to park managers to decide when to remove masks. The other parks haven't yet announced what measures they'd use to give the all clear.

While masking isn't required in most outdoor areas, it will be necessary for national park service buildings (like visitor centers, gift shops, offices, restaurants, and bus depots) and on all tour buses and shuttles. Currently, in Denali, Glacier, Grand Canyon, Grand Teton, Yellowstone, and Yosemite all visitors age two and older are required to wear masks in indoor areas, regardless of vaccination status.
